The challenge

With more than 50% of global disaster mortalities, the ASEAN region is the most disaster-prone region in the world. ASEAN has set in place robust legal and political mechanisms concerning institutions, systems, and processes to respond to disasters in the region. The AHA Centre serves to facilitate cooperation and coordination of disaster management amongst ASEAN Member States.

The AHA Centre aims to play a stronger role in facilitating capacity building for ASEAN Member States according to regionally and globally recognised standards, and to serve as a platform for exchange and repository of information sharing of lessons learned and best practices.

In order to become the leading organisation for ASEAN's disaster management and to play a stronger role in capacity building in the ASEAN member states and as a platform for the exchange and storage of information, the AHA-Centre needs to be equipped with strong institutional capacities and corporate units. Only in this way can it fulfil its operational functions. The managerial structures and capacities of the AHA-Centre can further be improved to fulfil its demanding tasks.


A trustworthy and effective coordination unit for disaster management and emergency response will strengthen regional cooperation among ASEAN member states and promote stability and security in the ASEAN region.
